- Organization must provide budget for the program area requested (i.e. food, rent, shelter, utilities, etc.).
- Organization may provide total operating budget with program area(s) as noted above.
- Organization must provide audit documentation according to [Wis. Stat. § 202.11](#) Statute, as amended by 2015 Assembly Bill 778. Each organization is responsible for following current WI State law regarding nonprofit audit filing requirements in place at time of application.
  - Org. with annual contributions over \$500,000 must file an audited financial statement prepared by an independent CPA.
  - Org. with annual contributions less than \$500,000 and over \$300,000 must file a financial statement reviewed by an independent CPA.
  - EFSP Local Board requires that Org. whose annual contributions are equal to or less than \$299,000 submit a letter that confirms a thorough review of the financial statements has been conducted and all is found to be in order. This letter must be signed by board chair or board treasurer and included with application.
- Agency/Organization must complete application, including Debarment or Suspension Certification on page 1.
